DoD to Inform Service Members Of Data Loss on Pay Statement

The Defense Department will inform service members who could be affected by the May theft of personal data from the Department of Veterans Affairs through their monthly pay statements.

DFAS will inform those service members who are determined to be vulnerable by putting a note on the bottom of their monthly leave and earnings statements. The note will include phone numbers and Web sites that will provide more information on identity theft and what troops can do to protect themselves.

The VA has set up a special Web site and a toll-free telephone number for those possibly affected by the data loss: www.firstgov.gov and 1-800-FED-INFO (1-800-333-4636). The Web site provides steps on how to check credit reports, how to guard against identity theft, and who to call if an individual believes any fraudulent activity is occurring with his or her personal information.
